A BILL TO: Appoint Undergraduate Students to the University Hearing Boards

THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

WHEREAS, The Student Hearing Boards are instrumental in protecting the rights of students at Michigan State University; and,


