**A BILL TO: Amend Article II, Section 7, sub-section A and B, and section 10 of the ASMSU Constitution to account for the Student Allocations Board and have it assume the responsibilities of the Programming Board, Funding Board, and Research Board.**

**THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:**

WHEREAS, There exist a Programming Board and a Funding Board per the ASMSU Constitution Article II section 7; and,

WHEREAS, The Programming Board exists to provide funding for CORES and COPS groups, and other activity departments to promote Programming of an all university nature to enrich the Spartan experience; and,

WHEREAS, The Funding Board exists to provide funding for RSOs for the purpose of promoting financial stability within RSOs and involvement around campus; and,

WHEREAS, The Research Board exists to provide students funding to attend a conference, educational workshop, symposium or scholarly competition that enhances an undergraduate student's education.

WHEREAS, Since their inception, the campus of Michigan State University has undergone great change culturally and financially; and,

WHEREAS, Programming Board and Funding Board have experienced difficulties adapting to a changing University; and,

WHEREAS, The Associated Students of Michigan State University seek to refine, reform, and refurbish its services to better suit the campus community; and,

WHEREAS, There has presented the unique opportunity to merge these two boards into a more stable body that will provide the functions of each while more appropriately adapting to current conditions at Michigan State University; and,

WHEREAS, This new board shall be called the Student Allocations Board and will assume the responsibilities of the two boards, with the inclusion of the Research Board and its powers; and,

WHEREAS, This board will be more adaptable, innovative, and connected to the Spartan community; therefore be it,

RESOLVED, **The Associated Students of Michigan State University propose the following change to Article II, Section 7 sub-section A and B, and section 10 of the ASMSU Constitution.**
