**A BILL TO: Amend the Senior Class Council Code of Operations**

**THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:**

WHEREAS, According to ASMSU's Code of Operations, Title Five Section 4 states, "The business and property of each Class Council shall be managed by its members. Class Councils may alter, amend, add to or repeal their respective Code of Operations as approved by a two-thirds (2/3) vote of the General Assembly;" and,

WHEREAS, The current Senior Class Council Code of Operations in Article V Section 6 reads, "SENIOR CLASS GIFT: The class gift committee shall coordinate the fundraising for the Senior Class Gift Campaign in cooperation with a gift campaign advisor who is a member of the University at large. As stipulated in the Senior Class Gift Campaign, each senior is given the option as to what part of Michigan State University they wish their donation to support;" and,

. WHEREAS, The proposed change to Article V Section 6 would read as followed, "SENIOR CLASS CAMPAIGN: The Campaign Committee shall coordinate the fundraising for the Senior Class Campaign in collaboration with an advisor from the Office of Annual Giving. This advisor shall be well versed in both the Office of Annual Giving and the ASMSU Senior Class Campaign. Furthermore, said advisor shall be an ex officio member to the SCC, and shall work alongside the ASMSU Vice President of Internal Administration to keep this committee on task. This committee shall highlight a major ASMSU theme for that year, a problem facing the university, or any initiative that benefits the students and senior class at Michigan State University as a whole. Said committee shall also have one senior student from the Office of Annual Giving and/or the Alumni Association;" and,

WHEREAS, Last week, the Senior Class Council voted to unanimously pass the proposed code change; therefore be it,

RESOLVED, That the General Assembly approves and amends Article V Section 6 of the Senior Class Council Code of Operations to read, " SENIOR CLASS CAMPAIGN: The Campaign Committee shall coordinate the fundraising for the Senior Class Campaign in collaboration with an advisor from the Office of Annual Giving. This advisor shall be well versed in both the

Office of Annual Giving and the ASMSU Senior Class Campaign. Furthermore, said advisor shall be an ex officio member to the SCC, and shall work alongside the ASMSU Vice President of Internal Administration to keep this committee on task. This committee shall highlight a major ASMSU theme for that year, a problem facing the university, or any initiative that benefits the students and senior class at Michigan State University as a whole. 
