A BILL TO: Confirm and Appoint At-Large Undergraduate Student Delegates to the University Council and the University-level Committees and Task-Forces

THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

WHEREAS, Article II of the Associated Students of Michigan State University Constitution states “The [General] Assembly shall create a process to nominate and appoint undergraduate students to university governance bodies²,” and,

WHEREAS, Michigan State University’s Academic Governance system grants ASMSU sixty-four (64) seats for undergraduate representatives; and,

WHEREAS, In accordance with the Academic Affairs Code (Appendix V of the ASMSU Manual), the Academic Affairs Nomination Commission has conducted formal reviews and nominations for at-large undergraduate students to the University Council and University-level committees

WHEREAS, In accordance with the Academic Affairs Code and MSU Academic Governance Bylaws, members of the Office of the President³ are appointed to the University Council and University-level committees; and,

WHEREAS, In accordance with the Academic Affairs Code, the Academic Affairs Nomination voted upon delegation placements by unanimous consent; therefore be it further,
