**A BILL TO: Amend Title Two of the General Assembly Code of Operations to  
Make the Google Form Survey the Standard Procedure for the OOTP Review and  
Introduce a Review Mechanism for Chief Officers**

**THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:**

**WHEREAS**, According to the General Assembly Code of Operations, Policy Committee is supposed to perform an annual Office of the President Review Board chaired by the Policy Committee Chairperson; and,

**WHEREAS**, According to the OOTP Review Board Handbook, the first meeting should occur “four cycles prior to the end of the Fall Semester” and the report should be prepared and “linked on the agenda at the last full session meeting of the semester”<sup>1</sup>; and,

**WHEREAS**, GA has had difficulty forming and filling committees so far this session, particularly during busy times of the year with final assignments and projects; and,

**WHEREAS**, OOTP must still be held accountable for their performances over the past year so that they can grow and do better in the future; and,

**WHEREAS**, As it is important for all GA members to comment on the performance of OOTP; and,

**WHEREAS**, The Google Form survey administered under Bill 61-37<sup>2</sup> in the fall semester was largely successful and well-received, demonstrating that the survey method is an

effective and accessible way to gather feedback from General Assembly members;  
and,

**WHEREAS**, It is important to maintain consistency and efficiency in the Office of the President (OOTP) review process; and,

**WHEREAS**, Recent legislation has addressed Chief Officers, and including a mechanism for reviewing them would provide valuable feedback and enhance accountability; therefore be it,

**RESOLVED**, That the Associated Students of Michigan State University shall amend Title Two, Section 21, Subsection G, Sub-Subsection 1 of the ASMSU Code as follows:

**(FROM)**

- A. The Policy Chairperson shall chair and conduct the OOTP Review Board in accordance with the OOTP Review Board Handbook.

**(TO)**

- A. The Policy Chairperson, **in conjunction with the Policy Committee Vice Chair and ASMSU Staff Advisor, shall administer an OOTP and Chief Officer Review Survey via survey. The results shall be provided to GA and the relevant parties anonymously during the last GA meeting of the fall session.**

**RESOLVED**, As such, the ASMSU OOTP Review Board Handbook is no longer applicable and shall be removed from official use; therefore be it further,

**RESOLVED**, Each member of GA shall be required to complete said survey by the time frame designated by the Policy Chair and Vice Chair, or else be penalized with an unexcused absence.




