**A BILL TO:** Establish a Student Body Presidential Election Implementation Ad-Hoc Committee

**THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:**

**WHEREAS,** In the 60th Session, the General Assembly passed Bill 60-05<sup>1</sup>, which established the ASMSU Student Body Presidential Election Research Ad-Hoc Committee; and,

**WHEREAS,** From the committee, the 60th Session passed Bill 60-62<sup>2</sup> which proposed a referendum in the Spring 2024 Elections regarding the popular election of the ASMSU and Student Body President; and,

**WHEREAS,** The referendum passed in the Spring 2024 Election with 80.2% of voters voting in favor of the referendum<sup>3</sup>; and,

**WHEREAS,** The referendum called for the implementation of this by Spring 2026 at the latest; therefore be it,

**RESOLVED,** That the Associated Students of Michigan State University shall establish the Student Body Presidential Election Implementation Ad-Hoc Committee which will be tasked with researching and implementing an open election for the ASMSU and Student Body President; therefore be it further,

**RESOLVED,** That the committee shall be chaired by the Vice President of Internal Administration during the given session and vice chaired by a General Assembly representative; therefore be it further,
