WHEREAS, The Associated Students of Michigan State University serves to “promote the health and wellness of undergraduate Spartans”¹; and,

WHEREAS, The goal of the HEAL (Healthcare, Education, Advocacy Leaders) Conference is to promote sexual health research and facilitate community engagement and discussion by showcasing the work of MSU community leaders²; and,

WHEREAS, Conversations of sexual health are important for creating safe student spaces and ensuring Spartans are aware of MSU sexual health initiatives; and,

WHEREAS, As MSU’s first “research and engagement based”³ conference dedicated to sexual health, its success is important to future student health initiatives; and,

WHEREAS, Towards the success of this conference, ASMSU’s financial support is necessary; therefore be it,

RESOLVED, That the Associated Students of Michigan State University shall allocate \$5000 from the General Fund (RY100000) to the Health Sexual Health Conference.



