A BILL TO: Waive Parts of the General Assembly Code of Operations Regarding the Operations of the OOTP Review Board & Instead Perform a Google Form Survey Organized by the Policy Committee Chair and Vice Chair

THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

WHEREAS, According to the General Assembly Code of Operations, Policy Committee is supposed to perform an annual Office of the President Review Board chaired by the Policy Committee Chairperson; and,

WHEREAS, According to the OOTP Review Board Handbook, the first meeting should occur "four cycles prior to the end of the Fall Semester" and the report should be prepared and "linked on the agenda at the last full session meeting of the semester," and,

WHEREAS, GA has had difficulty forming and filling committees so far this semester; and,

WHEREAS, Additional time commitments are difficult to add this late in the semester, with the pile up of final assignments and projects before break,

WHEREAS, OOTP must still be held accountable for their performances over the past few months so that they can grow and do better in the future; therefore be it,

WHEREAS, as it is important for all GA members to comment on the performance of OOTP,

RESOLVED, That the Associated Students of Michigan State University shall waive the Office of the President Review Board for the 61st Session and will instead distribute a Google Form Survey organized by the Policy Committee Chair, Isabelle

Radakovich, in conjunction with the Policy Committee Vice Chair, Genevieve Lucas, and the ASMSU Staff Advisor, Andrew Peckham, and any additional ASMSU Staff; and let it be further,

- **RESOLVED**, As such, ASMSU shall waive the ASMSU OOTP Review Board Handbook and the following clauses of the General Assembly Code of Operations for the remainder of the 61st Session:
 - Title Three Section 9: "The Office of the President shall be reviewed once annually by the Office of the President Review Board chaired by the acting chair of the Committee."
 - Title Two, Section 21, Subsection G, Sub-Subsection 1: "The Policy Chairperson shall chair and conduct the OOTP Review Board in accordance with the OOTP Review Board Handbook."
- **RESOLVED**, Each member of GA shall be required to complete said survey by the time frame designated by the Policy Chair and Vice Chair, or else be penalized with an unexcused absence

RESOLVED, The results will be provided to GA and OOTP anonymously during the last GA meeting of the fall session.
