THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

- **WHEREAS**, Voter turnout for recent General Assembly elections have been lacking due to an absence of outreach and recognition; and,
- WHEREAS, The need for better General Assembly recognition is made evident by the low voter turnout in Spring 2022 with 4.3% of the student population, Spring 2023 with 8% of the student population (slighter higher because it was a tax voting year), and Spring 2024 with just 3% of the student population; and,
- WHEREAS, Acknowledging the importance of student participation in undergraduate student government, the Freshman Class Council would like to create an MSU Dairy Store ice cream flavor promoting the upcoming ASMSU General Assembly elections with the intent of strengthening voter turnout; therefore be it,
- **RESOLVED**, That the Associated Students of Michigan State University shall allocate \$500 from the ASMSU General Fund to the ASMSU Class Councils-Freshman Class Councils in order to assist with prompting voter turnout of the ASMSU General Assembly Spring Election Cycle through the means of commissioning an MSU Dairy Store flavor.
