A BILL TO: Advocate for the Termination of Transitional Housing

THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

WHEREAS, A transitional housing has been utilized by Michigan State University to over-enroll students without providing the necessary resources to accommodate them adequately; and,

WHEREAS, Over 476 freshman and sophomore students started the 2024 school year in the transitional housing system with many claiming to experience some level of discomfort or displeasure with their living situation according to various recent reports¹; and,

WHEREAS, Students living in transitional housing have noted that the cramped and uncomfortable living conditions have left them feeling immense dissatisfaction in the transitional system and Michigan State Universities ability to handle student concerns²; and,

WHEREAS, Students who have been placed in transitional housing have noted that the cramped nature of their living situation has severely affected acclimation to life on campus and has made the moving process into dormitories increasingly stressful; and,

WHEREAS, In recent years, Michigan State students have frequently demanded an end to the transitional housing system, with the expectations of a more adequate system given the cost of on-campus housing; therefore be it,

RESOLVED, The Associated Students of Michigan State University shall advocate for the discontinuation of transitional housing at Michigan State University, in light of the

numerous issues that have arisen as a result and the growing concerns voiced by students; and let it be further,

RESOLVED, The Associated Students of Michigan State University shall release a statement in favor of the termination of the transitional housing system as a whole to make on-campus housing a more comfortable and stress-free living experience in conjunction with Bill 61-76 if passed; and let it be further,

RESOLVED, The Associated Students of Michigan State University shall continuously support future efforts to end transitional housing.



