**THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:**

**WHEREAS,** The MSU Center for Survivors is a campus and community resource that offers support and care to survivors of sexual assault, relationship violence, and stalking and harassment; and,

**WHEREAS,** The Center for Survivors has a Survivor Emergency Fund designated to be distributed to student survivors who are facing expense barriers related to a wide scope of issues including but not limited to education, transportation, or safety; and,


**WHEREAS,** The Survivor Emergency Fund is only funded through gifts from other campus partners or community individuals, meaning there is not a consistent flow of income to this resource; and,

**WHEREAS,** The Associated Students of Michigan State University has supported the Center for Survivors financially many times in the past<sup>123</sup>; therefore be it,


**RESOLVED,** That the Associated Students of Michigan State University shall allocate \$7,500 from the General Fund (RY100000) to the Center for Survivors Survivor Emergency Fund.


