#### THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

WHEREAS, The Office of Sustainability's The Campus Sustainability Student Projects Fund (CSSPF) is intended to support student-led projects geared towards sustainability and promote environmental practices for the betterment of Michigan State University; However the fund is raised through donations and is in need of the financial resources to further support sustainability projects; and,

WHEREAS, One of the most prominent projects funded by the CSSPF is the MSU Green Wall, installed in 2021. The Green Wall was planted along the Red Cedar River to enhance the landscape, improve air quality by filtering pollutants and producing oxygen. The planters used were made from recycled automotive plastics to ensure proper use of recycled materials and reduce single-use plastic wastage; and,

WHEREAS, These projects help MSU remain devoted to its sustainability initiatives and promote a greener future. MSU is dedicated to lessening the large carbon footprint of higher education as well as staying on track to remain a top 25 school for sustainability; therefore be it,

**RESOLVED**, That the Associated Students of Michigan State University shall allocate \$8000 from the ASMSU General Fund to the MSU Office of Sustainability to support on-campus sustainability projects and provide monetary means to the development and implementation of these projects and initiatives.
