A BILL TO: Amend Appendix V: ASMSU Academic Affairs Code to Designate Seats in Academic Governance

THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

WHEREAS, Appendix V: ASMSU Academic Affairs¹ code outlines the appointment process for undergraduate delegates to the MSU Academic Governance system; and,

WHEREAS, In accordance with the MSU Academic Governance Bylaws², members of the Office of the President are appointed to the University Council and University-level committees; and,

WHEREAS, In order for the ASMSU Manual to be in accordance with the MSU Academic Governance Bylaws and streamline the appointment process, the Academic Affairs Code should be amended to designate specific seats for the ASMSU President, Vice President for Academic Affairs, and other ASMSU staff members; therefore be it,

RESOLVED, That the Associated Students of Michigan State University shall amend Title Four of Appendix V: ASMSU Academic Affairs Code to add a new tab that includes Section 8 as follows:

Section 8. ASMSU shall designate seats in Academic Governance for Office of the President members and certain ASMSU staff members including the following:

- A. The ASMSU President shall serve on the University Council, University Steering Committee, and the University Committee on Student Life and Engagement (UCSLE)
- B. The Vice President for Academic Affairs shall serve on the University Council, University Steering Committee, and the

- University Committee on Undergraduate Education (UCUE); The Vice President for Academic Affairs shall serve as an *ex-officio* member of the Faculty Senate
- C. The Associate Vice President for Academic Affairs shall serve on the University Council and the University Committee on Academic Governance (UCAG)
- D. The Director of Student Rights Advocates and Legal Services shall serve on the University Committee on Student Life Engagement (UCSLE)
