## THE ASSOCIATED STUDENTS OF MICHIGAN STATE UNIVERSITY ENACT:

**WHEREAS**, The 61st General Assembly will see Bill 61-94, which amends the code to add an ASMSU Ethics Oversight Committee<sup>1</sup>; and,

**WHEREAS,** Bill 61-94 will add duties to the Vice President for Governmental Affairs to serve as the Chair of the ASMSU Ethics Oversight Committee; therefore be it,

**RESOLVED**, That the Associated Students of Michigan State University shall amend Title III, Section 5 of the General Assembly Code of Operations as follows:

## (FROM):

Section 5. There shall exist an ASMSU Vice President for Governmental Affairs (VPGA) who shall be selected as specified in Title II, Section 34 of the ASMSU Code of Operations. The responsibilities of the VPGA shall be as follows:

- A. Serve as senior *ex-officio* member of the Policy committee.
- B. Supervise the Governmental Affairs Department.
- C. Oversee the governmental advocacy and civic engagement activities of the Association.
- D. Others as specified by the Constitution, this Code of Operations, and the official ASMSU President job description
- E. Shall have a broad and comprehensive knowledge of the Association and the university.
